
# **LiLI Express Borrowing Policy**

**Purpose:** The LiLI Express program represents a means to improve library services to Idaho citizens through a cooperative, reciprocal borrowing agreement among libraries.

### **Definitions:**

<u>Home library:</u> (1) the library whose primary mission is to serve the patron by virtue of enrollment, residence, or employment, or (2) A library that issues the patron a non-resident card. A patron of a participating library may obtain a non-resident "home library" card at any of the participating, publicly-funded public libraries by paying the non-resident fee of that library.

<u>Patron:</u> Any Idaho citizen 18 years of age or older. Serving younger patrons is at the discretion of the lending library.

<u>Service:</u> The loan of books to patrons on site. Providing additional services is at the discretion of the lending library.

<u>LiLI:</u> Libraries Linking Idaho, a service of the Idaho Commission for Libraries, is an alliance of library and library networks joined together to further the common good. It provides the Idaho library community with services that are more economical when administered at a statewide level rather than at a local or regional level.

## **LiLI Express Guidelines for Borrowers:**

- § A LiLI Express visitor card may be obtained by showing a valid library card from the patron's home library and a photo ID.
- § The LiLI Express visitor card is good only at participating LiLI Express libraries.
- § The LiLI Express visitor card is good for a period of one year, and may be renewed after that.
- § Borrowers with a LiLI Express visitor card may check out only 2 items at any one time.

### **Borrower Responsibilities:**

- § Maintain my record of good-standing at my home library,
- § Permit the lending library to contact my home library to periodically verify that I am a patron in good standing,
- § Return materials I borrow to the library from which they were borrowed,
- § Return materials in a timely manner according to the rules of the lending library, and

§ Assume responsibility for all material materials, overdue fines, or other fees	als borrowed, including payment for lost/damaged .
